Rocky Mountain Stone Products warrants its products for a period of 50 years from the date of installation, at the address registered on this warranty, to be from manufacturing defects and will not need painting because there is no paint to chip, peel, blister, or flake since Rocky Mountain Stone Products are an all masonry product. Rocky Mountain Stone further warrants its product against denting because of its masonry construction. Rocky Mountain Stone Products further warrants its product against rust to corrosion, crazing, flaking, and unsightly discoloration. Rocky Mountain Stone Products will remedy all product failure covered by this paragraph by repair or replacement of faulty stone, without charge to the owner, in accordance with the applicable terms and conditions of this warranty.

This warranty covers only manufacturing defects in Rocky Mountain Stone Veneer manufactured by Rocky Mountain Stone Products. This warranty does not include damages from faulty or improper installation, willful abuse, misuse or negligence or damage resulting from fire, lightning, earthquake, or other Acts of God. Also any interruption in the settlement of the building, failure of the structure (including foundations and walls), surface discoloration due to air pollution, exposure to harmful chemicals, normal weathering of surface, efflorescence or oxidation, or other causes beyond the control of manufacturer are excluded from this warranty.

This warranty shall be valid only after the registration certificate is filed by the Rocky Mountain Stone Dealer, signed by the original purchaser and mailed to Rocky Mountain Stone Products within thirty (30) days after completion of installation. In the event Rocky Mountain Stone Products is not notified in writing of any problems. Rocky Mountain Stone Products shall be relieved of all obligations hereunder.

Rocky Mountain Stone Products reserves the right to discontinue and/or make changes in any of its products. In the event the products covered by this warranty are not available. Rocky Mountain Stone shall have the right to substitute products that, in Rocky Mountain Stone's sole discretion, is of equal quality or price.

ROCKY MOUNTAIN STONE PRODUCTS MAKES NO EXPRESS WARRANTIES, EXCEPT AS ARE SET FORTH HEREIN AND SHALL NOT BE LIABLE FOR ANY INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES WITH RESPECT TO THE ROCKY MOUNTAIN'S COMPLETE LIABILITY AND THE OWNERS EXCLUSIVE REMEDY BEING LIMITED TO REPAIR OR REPLACEMENT ON THE BASIS STATED HEREIN.
